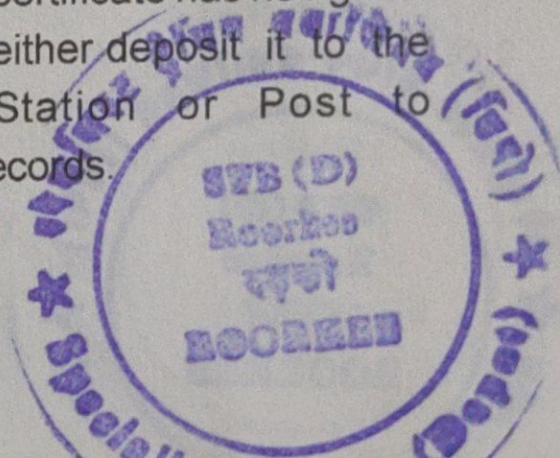

- (c) Finder of this certificate has no right to retain it. He should either deposit it to the nearest Police Station or Post to Officer-in-Charge, Records.

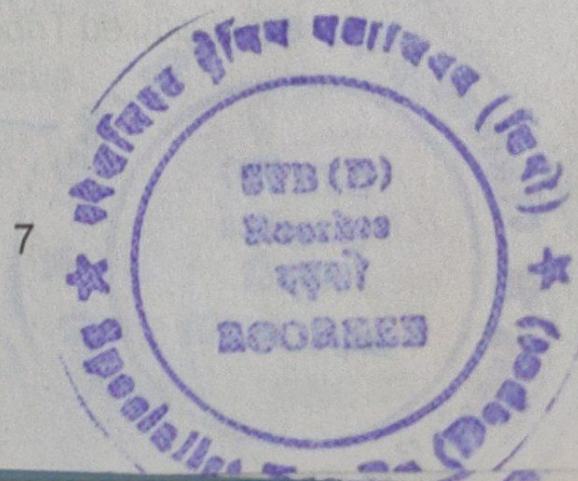
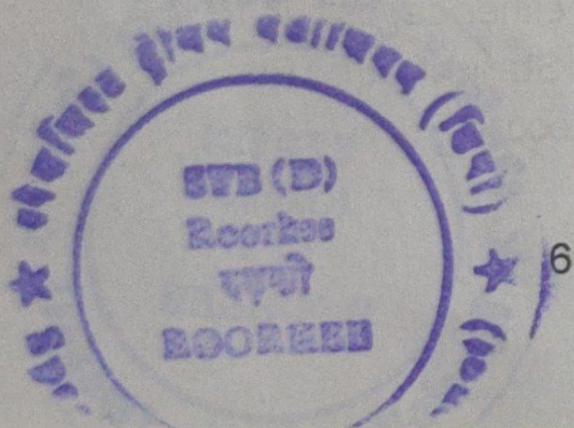
