(g) Brief description of circumstances leading to case.

On 22 Mar 2009, as squad commander No 15134004K Hav Bhakare Sanjay Annasaheb acted on specific information of a terrorist hiding in the village upper Haphruda and cordoned the suspect house. Sensing grave danger to civilians, as the terrorist opened indiscriminate fire, he displayed mellifluous composure and evacuated all the civilians from the immediate vicinity of the house. The terrorist came out blindly firing in a suicidal act and escape into close by forest. The vigilant Non Commissioned Officer followed the fleeing terrorist in the dense undergrowth and killed him. In the ensuing firefight he received Gun Shot Wound to his head and succumbed to injury as he made the supreme sacrifice beyond the call of duty in the true spirit of a soldier of Indian Army.
