Respected Sir,

I am privilege to bring to your kind attention to an important matter that needs immediate consideration. (pls refer trailing mail from 7 Dec 2023 to admission registrar) As an ex-serviceman, I am deeply concerned about the lack of reservation for wards of ex-servicemen in the admissions process at National Law University Nagpur.

I am projecting a matter of significant concern regarding the disparity in the implementation of reservation for exservicemen's wards across National Law Universities Nagpur. I would like to bring to your **notice that while NLU Mumbai and NLU Aurangabad are providing reservation for ex-servicemen's wards, but NLU Nagpur does not have a similar provision while going through admission process.** This disparity has deprived them golden opportunity of getting admission in premier institute like NLU Nagpur.

As per reference letter No-1 (State Govt notification) it had mentioned that

- 3.2.0. Reservation for son/daughters of defence service personnel: -
- 1.2.1. Five (5) percent of the total sanctioned intake, subject to maximum of five (5) seats in each government university depts. On govt aided and un- aided institutes shall be reserved for children of defence service personnel and Ex-service defence personnel including those permanently disable or killed in action, in case of un-aided institutes.... (Pls ref letter no-1 last 3 pages)

It is disheartening to note that NLU Nagpur currently does not provide reservation benefits to the wards of exservicemen since its establishment year 2016, while other NLUs in the region are meticulously providing the reservations benefits to the wards of serving/ex-servicemen. This omission not only neglects the contributions and sacrifices of ex-servicemen but also denies their children the opportunity to pursue education in a prestigious institution like National Law University. This lack of uniformity is not only unjust but also creates a sense of exclusion for ex-servicemen and their families.

Ex-servicemen have dedicated their lives while serving the nation, often in challenging and high-risk environments. The sacrifices and contributions made by ex-servicemen deserved to be acknowledged and honour. The reservation for ex-servicemen's wards in educational institutions is a rightful and justifiable provision, aimed at ensuring that their sacrifices are recognized and that their children have access to quality education.

I urge you to urgently reconsider Govt. policies on the subject and align them with the provisions for wards of exservicemen's reservation that are in place at NLU Mumbai and Aurangabad. I believe that by addressing this disparity and extending reservation benefits to ex-servicemen's wards, NLU Nagpur can set a positive example and contribute to a more inclusive and supportive educational environment for the children of ex-servicemen in the region.


