(c) This is lieu of / suppression of invalid / service pension notified in PPO NO..... the pension of which is held in abeyance except the amount of retirement gratuity and CVP till this award is in issue. All payments made except D.C.R.G. & C.V.P. will be adjusted against the arrear of WIP/WIE. Due before making first payment.

(2) A certificate from the widow that she is not in receipt of any other family pension in respect of the deceased pensioner should invariably be taken before making any payment of family pension to her.
