- (b) Loss of this Certificate is to be reported to the nearest Police Station and a copy of FIR obtained.





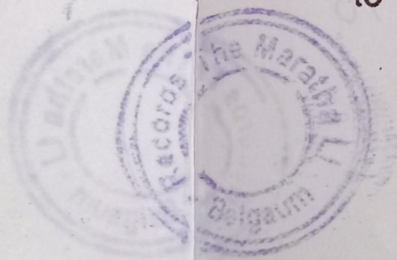

(d) This Discharge Book is not transferable. Amendments, alteration, erasures of entries or any attempt at tampering constitutes a grave offence and will render the persons concerned liable to prosecution. Amendments if necessary to be effected only under the seal of Officer I/C, Records.
