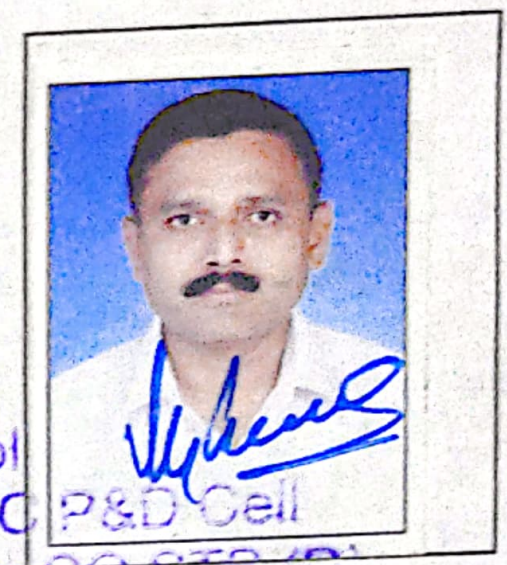

(d) This Discharge Book is not transferable. Amendments, alteration, erasures of entries or any attempt at tempering constitutes a grave offence and will render the person concerned liable to prosecution. Amendments, if necessary to be effected only under the seal of Officer I/c Records.
