

This certificate is divided into three parts as follows :-

- PART I. Civil and Service particulars.
- PART II. Certificate of Transfer to the Regular Air Force Reserve.
- PART III. Certificate of Discharge.

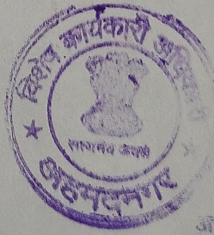
PART I is to be completed in respect of all airmen to whom this certificate is issued.

PART II is to be completed only if the individual is transferred to the Regular Air Force Reserve. In that case, Part III is to be left blank for completion at the expiry of his Reserve Service.

PART III is to be completed as follows:-

(a) If the airman is being discharged without this part will be completed at the time of case, Part II will be crossed out in ink as signed by the O.C. Unit.

(b) If the airman is being transferred to the Reserve, then this part is to be left blank for transfer. It will be completed when the expiry of his Reserve Service.

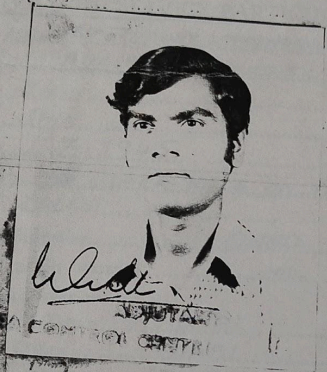
