The individual sustained **"WOUNDED DUE TO CAR BOMB EXPLOSION BY TERRORISTS WHILE ON SENTRY DUTY"** in Operation RAKSHAK in Jammu & Kashmir on 25 Dec 2000. The injury was declared as **Battle Casualty** vide Records The MARATHA LI Part II order No **R/BC/3/9/2001**. The disability percentage assessed by Medical Board is **20 %** for life and board recommended the disability as **Attributable to Military Service**.
