- (b) Loss of this Certificate is to be reported to the nearest Police Station and a copy of FIR obtained.

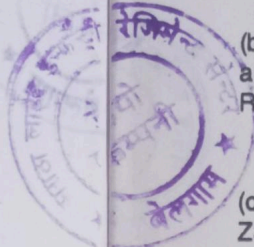
