

CHILDREN PENSION

Children Pension shall be payable to not more than two children at a time. In the event of any one or both of the children who have been getting pension, becoming non-entitled due to the happening of any event as in (ii) above, the children pension shall be paid to the next eldest surviving child/children till the attainment of age of 25 years

V. ORPHAN PENSION

In the event of cessation of widow/widower pension due to death or re-marriage of the widow/widower, the children shall be paid Monthly Orphan Pension, in lieu of the Monthly Children Pension at the rate of Rs.389 each per month. The payment should commence from the date following the date of death/re-marriage of widow/widower. The Monthly Orphan Pension shall continue to be paid till the date of attaining the age of 25 Yrs.

VI. DEPENDENT PENSION

In the case of death of the member who had not have surviving spouse and/or surviving child and/or a month/variable pension at the rate indicated below against the nominee shall be payable.

VII. COMMUTED VALUE OF PENSION

Shri/Smt. VILUP N PATEL (Member pensioner) shall be paid a lumpsum amount of Rs/- being the commuted value of pension for 100 times the commuted pension by the disbursing agency, as per part of PART-III of the pensioner's portion is, after verifying the details of the said recipient and after taking from him/her a receipt of said amount according to the prescribed form.

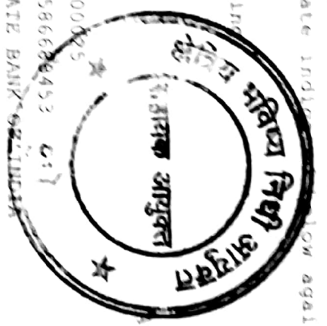
VIII. PAYOUT OF CAPITAL VALUE
