- (b) Any query, request or complaint against Govt. authority is to be made to Officer-in-Charge Records concerned.
- (c) Soldier is to Report to the nearest RSB/ZSB for assistance in finding employment and is to get his name registered, with them.

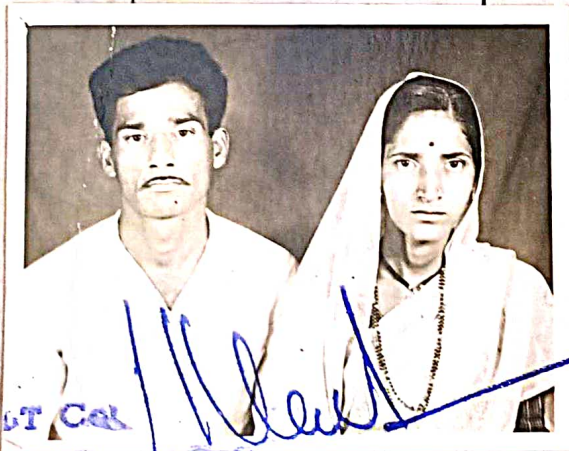
