

EQUATION OF EDUCATIONAL QUALIFICATIONS GRADUATION CERTIFICATE

Government of India Ministry of Personnel, Public Grievances, Pension (Department) of Personnel & Training) Letter No. 15012/8/82 Estt. (D) dated 12th February, 1986. AND THE GAZETTE OF INDIA No. 9, DATED 1ST MARCH, 1986.

1. C S.R. in exercise of the powers conferred by the proviso to article 309 of the constitution the President hereby make the following rules further to amend the ex-serviceman (Re-employment Central Civil Services & Post) Rules 1979, namely. :

These rules may be called the ex-serviceman (Re-employment in Central Civil Services & posts) Amendment Rules, 1986.

- 2. In rule 6 of the Ex-serviceman (Re-employment in Central Civil services and posts) rule 1979 [hereinafter referred to us the said rules] after subrules (3) the following shall be inserted namely:
- [a] for appointment to any reserved vacancy in Group 'C' Posts a matriculate ex-servicemen [which term includes an ex-serviceman who has obtained the Indian Army special certificates of Education or the corresponding certificate in the Navy or the Air Force who has put in not less than 15 years of service in the Armed Forces of the Union may be considered eligible for appointment to the posts for which the essential educational qualification prescribed is Graduation and where [b] work experience of technical or professional nature is note essential : or
- [c] Through nontechnical professional work experience is prescribed as essential yet the appointing authority is satisfied that ex-servicemen is expected to perform theduties of the post by undergoing in the job training for a short duration.
- [d] For appointment to any reserved vacancy in Group C & Group D, posts where the prescribed minimum education qualification is matriculation the appointing authority may at his discretion relax the minimum educational qualification in favour of ex-servicemen who has passed the Indian Army Class 'I' Examination of equivalent examination in the Navy or the Air Force and who has put in atleast 15 years of service in the Armed Force of the Union and is othervise considered fit to hold the post, in view of his experience and other qualification.
- 3. Therefore Name: SHADIVAN DILAWAR GULMAHAMAD CHME Rank: Who is pensioner and ex-servicemen is eligible for the appointment where educational qualification is essential GRADUATION.
