

#### Note

- a) The enhance family pension is payable for 07 years from the date following the date of death of pensioner or efp upto date printed in this PPO whichever is earlier.
- b) Dearness relief shall also be payable subject to terms and condition as hitherto fore.

#### A. Instructions for post-2006 cases

- The general instructions relating to payment of dearness relief supplied with Original PPO stands deleted. Dearness Relief on Pension/Family Pension
  is payable in addition from 1-7-2006 or the date of commencement of pension whichever is later in terms of Min of PPG & Pensions Dept. Of P & PW
  OM No. 42/2/08 & PW (G) Dt. 12-09-2008 & further at the rate as notified from time to time.
- 2. Payment of Dearness Relief on pre-revised pension and all the interim relief w.e.f. 1.1.2006 and onwards shall be adjusted before making any payment on the authority of this PPO.
- Consequent to upward revision of commutation, the reduction in the amount of pension shall be made from the date of receipt of the revised commuted value of pension by the pensioner or three months after the date of issue of the authority.
- 4. No changes in instruction supplied with original PPO for payment of commuted value, reduction in pension, restoration of pension are remains in force.
- 5. Medical Allowance authorised on the authority of this PPO is payable w.e.f. the date printed in the PPO otherwise w.e.f. the date of issue of this PPO.
- 6. Dearness relief is not admissible on the account of CAA and Gallantry awards.
- 7. Constant Attendant Allowance is admissible subject to production of following certificate.
- i). He was not an inmate or impatatient of Govt. Hospital or Institution.
- ii). He has actually employed an attendant to look after him for which CAA has been claimed.
- B. Instruction for pre 2006 cases irrespective of date of retirement.
- 1. Dearness Relief on revised pension as notified from time to time after 01-01-2006 is payable in addition.
- 2. All payments made with effect from 01.01.2006 except Adhoc Ex-Gratia sanctioned to pre 01.01.1973 pensioners, Monetary allowance attached to Gallantry Award such as Param Vir Chakra, Shaurya Chakra etc., are to be adjusted against the awards now notified which will be payable in addition, wherever admissible.
- 3. No interim relief/personal pension is payable w.e.f. 01.01.2006.
- 4. In case pension/family pension now revised is less than the existing pension/family pension drawn by the pensioner the pensioner which is more beneficial is payable to the pensioner.
- 5. The revised awards have been updated after taking into account the benefits of modified provisions contained in Min. Of Defence letter No. 17(4)/2008 (i)/D (Pen/Policy) dated 11.11.2008.
- 6. Pensionary awards notified in the original PPO/Corr PPO but not referred in this PPO thereby remained unrevised shall remain unchanged.
- 7. In case where a portion of pension has been commuted and not restored, the same shall continue to be deducted from the revised pension till the date of restoration.
- 8. All payments made with effect from 01.01.2006 shall be adjusted against the revised awards notified in this PPO.
- 9. In case where recovery from pension is in progress, the same may be adjusted in full form the arrears of the revised awards notified in this PPO.
- 10. The revised pension have been notified after taking into account the benefits of the previous contained in PCDA(Pensions) Allahabad circular No. 397 dated 18.11.2008, No. 430 dated 10.03.2010, No. 453 dated 22.02.2011, No. 456 dated 18.03.2011 and circular No. 461 dated 11.05.2011, No. 501 dated 17.01.2013, No. 502 dated 17.01.2013 and circular No. 503 dated 17.01.2013.
- 11. The conditions/instructions for payment of pension/retirement gratuity/Commuted value of Pension/Gallantry Award/Dearness Relief/ordinary Family Pension/Constant Attendance Allowance contained in Defence Pension Payment instruction (Defence PPI) 2005 Edn., as amended from time to time as well as in various circulars issued from time to time by the PCDA (Pensions) Allahabad, shall continue to be operative. The requirements of obtaining various certificates before making payment shall also remain continue.
