CONDITIONS FOR ISSUE OF DUPLICATE DISCHARGE BOOK

- (d) This Discharge Book is not transferable. Amendments, alteration, erasures of entries or any attempt at tampering constitutes a grave offence and will render the persons concerned liable to prosecution. Amendments if necessary to be effected only under the seal of Officer i/c Records.
