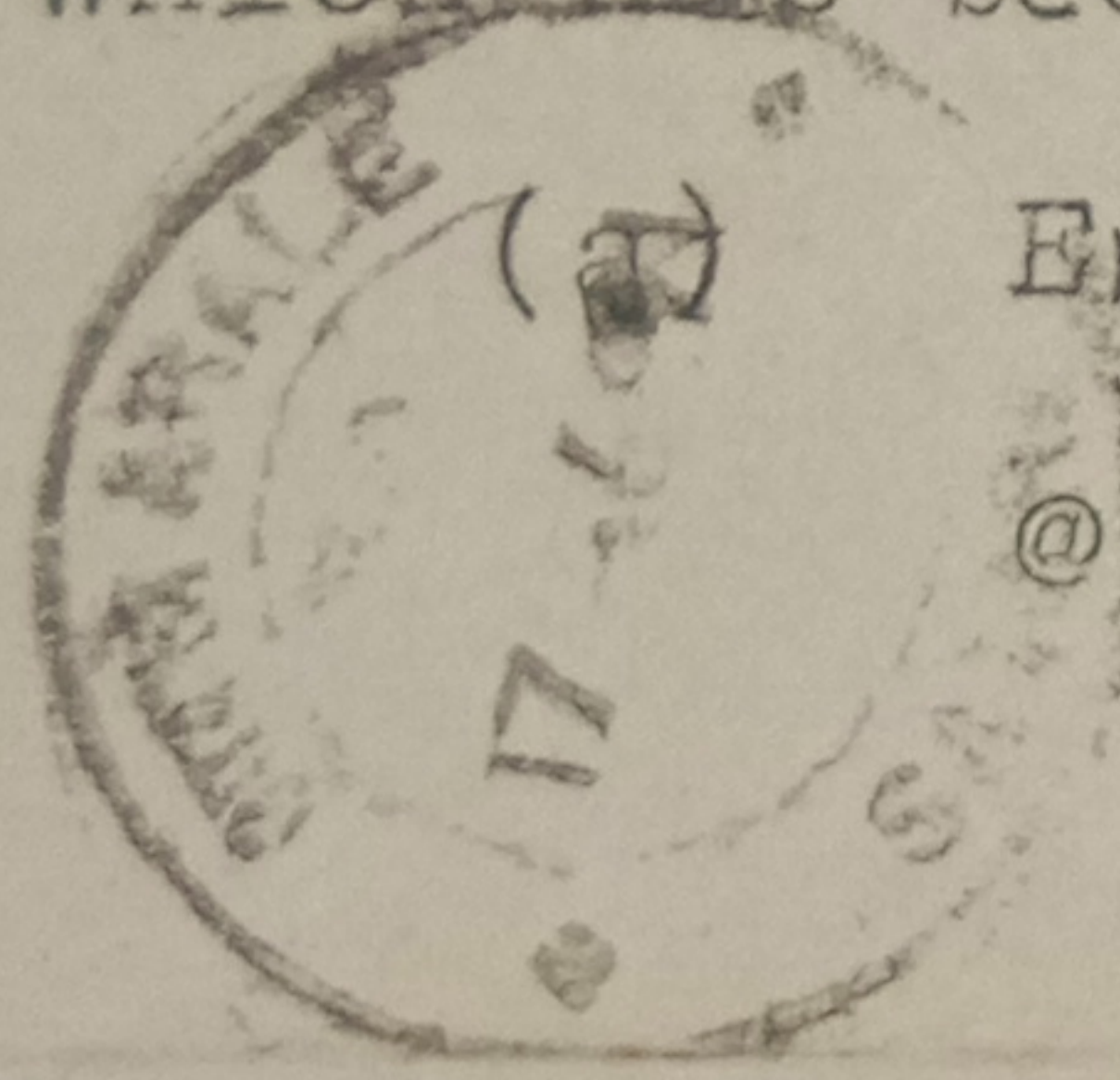

SERVICE PENSION

1. You have been granted Service Pension, DCF Gratuity and capitalised value of commuted pension vide CDA(P) Allahabad Pension Payment Order no S/C/ 29697 /83 :-

- (a) (i) Service Pension Rs 144 /pm from 1-8-83 for life which will be reduced to Rs 80/- /pm from the date of payment of the commuted value vide (c) below or three months after issue of the above PPO which ever is earlier.
(ii) Relief 50% % pm is payable in addition.
(b) DCR Gratuity Rs 3621.90
(c) Capitalised value of commuted pension Rs 12994.55
