PART - I**CONDITIONS FOR ISSUE OF
DUPLICATE DISCHARGE BOOK**

1. (a) This Discharge Book must be preserved carefully. If this is lost, A DUPLICATE COPY WILL NOT BE ISSUED. Only exceptional circumstances and at the discretion of Officer I/C Records a duplicate certificate can be issued. Officer I/C Records must be informed of the cause of loss immediately on occurrence, through the Secretary Zilla Sainik Board.

(b) Loss of this Certificate is to be reported to the nearest Police Station and a copy of FIR obtained.



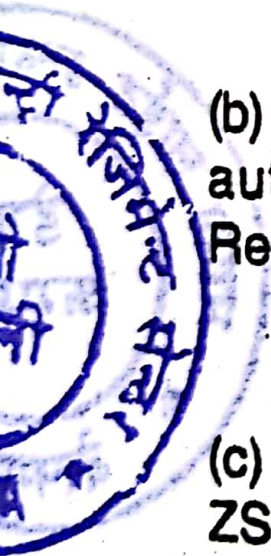
(c) A finder of this certificate has no right to retain it. He should either deposit it at the nearest Police Station or post to Officer-in-Charge Records, The MARATHA LIRC, Belgaum - 590 009.

(d) This Discharge Book is not transferable. Amendments, alteration, erasures of entries or any attempt at tampering constitutes a grave offence and will render the persons concerned liable to prosecution. Amendments if necessary to be effected only under the seal of Officer I/C, Records.
