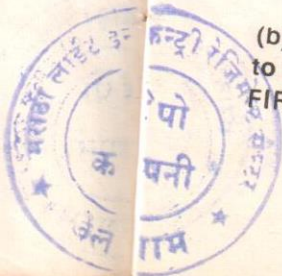

Officer i/c Records must be informed of the cause of loss immediately on occurrence, through the Secretary Zila Sainik Board.
- (b) Loss of this certificate is to be reported to the nearest Police Station and a copy of FIR obtained.

(d) This Discharge Book is not transferable. Amendments, alteration, erasures of entries or any attempt at tampering constitutes a grave offence and will render the persons concerned liable to prosecution. Amendments if necessary to be effected only under the seal of Officer i/c Records.

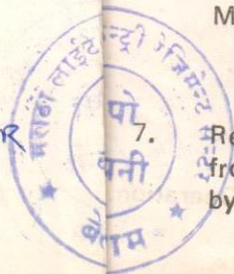

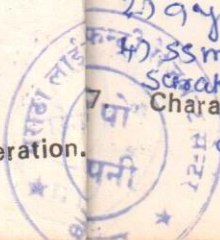

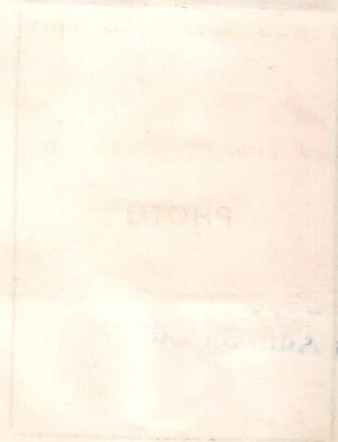
