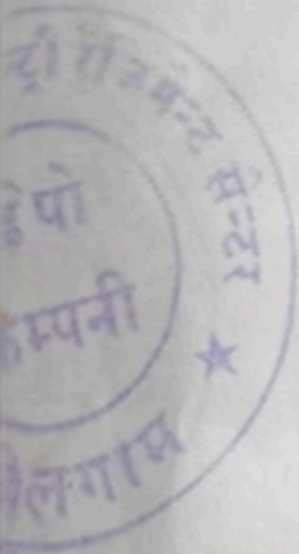

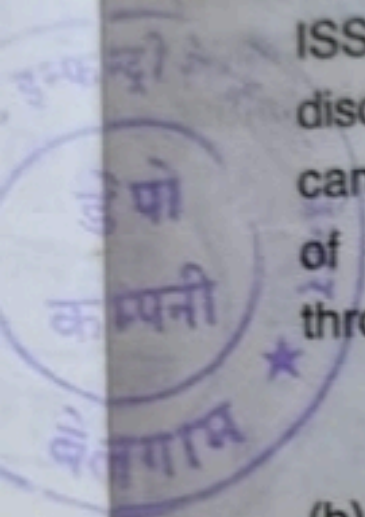

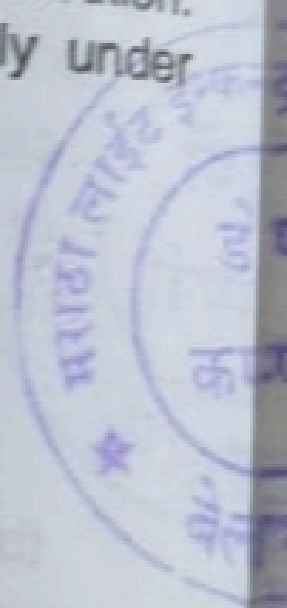
PART - I**CONDITIONS FOR ISSUE OF
