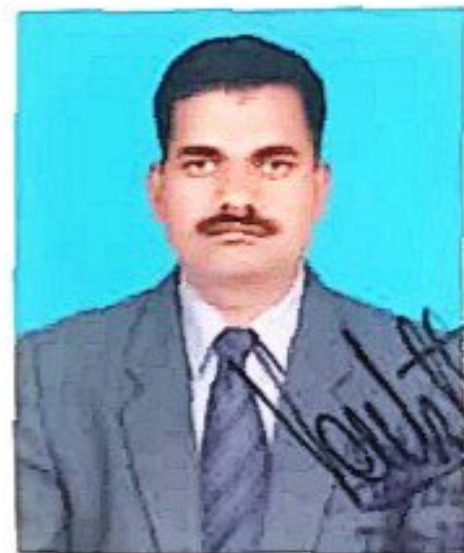

- (b) Loss of this Certificate is to be reported to the nearest Police Station and a copy of FIR obtained.



(ii) A holder of this certificate has no right to retain it. He should either deposit it at the nearest Police Station or post to Officer-in-Charge Records, The MARATHA LIRC, Bangalore 560 009.

(iii) The Discharge Book is not transferable. Amendments, alteration, erasures of entries or any attempt at tampering constitutes a grave offence and will render the persons concerned liable to prosecution. Amendments if necessary to be effected only under the seal of Officer IC, Records.

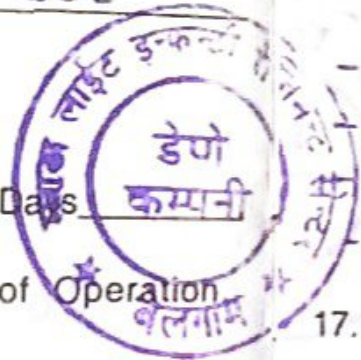
