A sum of Rs. 3, 42,601/- (RUPEES THREE LAKH FORTY TWO THOUSAND SIX HUNDRED ONE ONLY) already paid upto 31/07/2018 on a/c of PEA is to be recovered before making first payment.

A sum of {Rs. 3, 03,521/- {DCRG} - Rs. 15,000/- {ECHS}} = Rs. 2, 88,521/- (RUPEES TWO LAKH EIGHTY EIGHT THOUSAND FIVE HUNDRED TWENTY ONE ONLY) is to be paid in addition on a/c of DCRG. If however, the claimant dies before receiving this amount, the payment on this a/c is not be made to heir (s) and the matter should be reported to this office.


Note:

- (i) Dearness Relief as sanctioned by the Govt. from time to time is also admissible in addition.
- (ii) Payments made against this PPO are to be re-imbursed by PCDA (P) Allahabad (UP).
- (iii) First payment of family pension will be made only if claimant is alive & eligible. Otherwise PPO will be treated as cancelled & returned for cancellation.
- (iv) Before making payment of family pension, a certificate to the effect that the widow has not re-married should invariably be obtained.
- (v) The employment under Govt. will not be a disqualification.
- (vi) Payment of OFP will be discontinued if the widow remarries even with the real brother of the deceased.
- (vii) Smt. Vidya Sudakar Dhorke Aadhar No. 903311897832.
- (viii) DCRG has been equally divided between wife, Son & daughter. Son & daughter have been sanctioned DCRG vide PPO no. 08/14/B/F/P/0513/2018 & 08/14/B/F/P/0514/2018.
