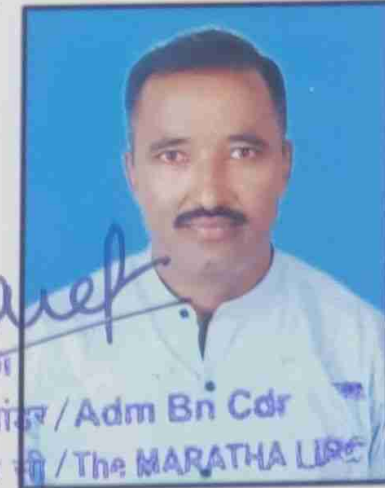
**CONDITIONS FOR ISSUE OF DUPLICATE
