(a) Debitable to Defence Services (Army/) Estimates.

(b) Temporary Increase/AHI/AHR Are not payable in addition.

(c) The award is subject to modification in the event of the competent pension sanctioning authority, deciding as a result of further medical examination of the individual for any purpose that the individual's disability is reduced or has disappeared or has become capable of improvement.

(d) This is in lieu of supercession of invalid service pension notified in PPO No. the pension of which is held in *re*obeyance wef. All payment made except DCRG will be adjusted against the arrears of disability pension now due before making first payment.

(e) Represents the amount of service element. In the event of the continuation award of disability pension being sanctioned, payment of service element made for the period covered by the continuation award of disability pension shall be adjusted in full before making first payment.

(f) A lump sum amount of Rs.9975.00 (Rs. Nine thousand nine hundred **seventy five only.**) on account of DCRG will be paid in addition at

the time of first payment. If, however the individual dies before making payment the payment should not be made to his heir (s), and the matter referred to G-4 Section of this Office for further instructions.

(g) The above individual has commuted a sum of Rs. 168/- PM out of his above disability pension of Rs. 465/- PM for a capitalised sum of Rs. 32881/- (Rs. **Thirty two thousand eight hundred eighty one only.**) The capitalised sum may please be paid to him on or after 4.9.87 provided he is alive on that date. As a result of this his pension will be reduced to Rs. 297/- (Rs. **Two hundred ninety seven only.**) PM wef the date of payment of the commuted value or three months after the date of issue of this PPO (See the date of despatch given below) whichever is earlier and service element of Rs. 375/- will be reduced to Rs. 207/- from 31.7.89 onwards.

(h) The following reliefs are payable in addition. 8% (Eight percent) 4.9.87onwards. The payment of relief is subject to the usual condition governing the grant of Temporary increase.

7 years from the date following the death of the pensioner or upto 5.8.2015. or till death or remarriage whichever is earlier. Thereafter.

(B) Normal rate @ Rs. 375/- (Rs. Three hundred seventy five only) till death or remarriage whichever is earlier.

Relief on F. P. is payable in addition :- 8% (Eight percent only). or as admissible from time to time.

NOTE :-

1. Family pension as sanctioned above is payable only after receipt of the death certificate of the pensioner mentioned in Cage (A) above and a report thereof submitted to Audit Section of this office.
2. The stipulations regarding the commencement & correction of various rates of F. P. should please be carefully noted for guidance and rate of relief on F. P. regulated accordingly.
3. The amount of relief is to be worked out on the gross amount of F. P. shown in column 4 in Cage (B) above and stipulated in various circulars on 'RELIEF' issued from time to time.
4. A certificate from the widow that she is not in receipt of any other family pension should invariably be taken before making any payment of F. P. to her.
