ORDER UNDER SECTION 80G (5)(vi) OF THE INCOME TAX ACT, 1961 READ WITH RULE 11AA OF THE INCOME TAX RULES 1962.

Donations made to the Trust/Society, namely, Armed Forces Flag Day Fund, Maharashtra State, Sainik Kalyan Vibhag, Raigad Building Opposite National War Memorial, Ghorpadi, Pune, will be eligible for the benefit of deduction under section 80G of the Income Tax Act, 1961, in the hands of the donors subject to the limits and conditions prescribed therein.

- 2. The above approval shall remain valid from 01/01/2014 until withdrawn. This is subject to adherence to the following:
 - (i) Receipts issued to the donors should bear the Reference Number and date of this order.
 - (ii) The Return of Income accompanied by Statement of Accounts and Income & Expenditure Account, Balance Sheet of the above Trust / Society should be submitted to the concerned Assessing Officer within the specified due date(s) laid down in the Income-tax Act.
 - (iii) Consequent to the amendment of section 2(15) of the Income -tax Act, 1961 w.e.f. 01/04/2009, if a Trust/ Society/Institution/ Society carries on any activity in the nature of trade, commerce or business for a cess or fees or any other consideration, exemption u/s 80G granted will be withdrawn irrespective of the nature of use or application, or retention of the income from such activity.
